Purpose

To orient legal aid lawyers re. the new exceptional circumstances payments request policy, process

To answer questions and address concerns

Exceptional Circumstances (EC) Payments Policy

("Additional Hours")

Legal Aid tariff normally applies

Exceptional circumstances payment assessed by PB Clerk (up to 10 hrs.), PB Director (10 hrs. plus)

How to make a request – complete form, email with account

Guidelines with specific eligibility criteria – results obtained, complexity, forensic evidence, etc. Principles for EC payments – onus on lawyer to provide sufficient information to justify EC payment

Legal Aid tariff normally applies

The LAS Legal Aid Tariff of Fees, Schedule "A" General Conditions states:

- This tariff is intended to reflect fees that would customarily be paid by a client of modest means. The Chief Executive Officer may if a solicitor can show extremely exceptional circumstances due to:
 - the nature of the offence,
 - complexity of the case, and/or
 - any other factors that would warrant an increase in preparation time for the file, provided in his/her opinion an increase is justified.

CEO authority is delegated to the Private Bar Services Director pursuant to *Legal Aid Act*

Do lawyers need to request approval of "additional hours" prior to the hours being spent? No



Counsel will no longer request "additional hours" approval prior to the hours being spent

It is easier for the bar and LAS	The bar only has to contact LAS once regarding the additional hours – at the time of billing.
	LAS only has to touch the account once. Staff do not have to review a request for additional hours in advance of billing.



Many private bar members do not know how many additional hours to request prior to the matter being heard/dealt with, and LAS does not know how many hours to approve.



Exceptional circumstances Guidelines provide clarity as to when hours may be granted providing the private bar with some certainty

What are the exceptional circumstances Guidelines?

The Guidelines describe and clarify in accordance with the Rules, exceptional circumstances for which a lawyer may be eligible for an increased payment above tariff.

The Guidelines are not exhaustive

The onus (burden) is on the lawyer to provide sufficient details and explanation as to how the matter meets the exceptional circumstances test. Simply indicating one of the guidelines has been met is not sufficient.

Once the exceptional circumstances criteria are met, LAS will determine the amount of payment taking into consideration

- What is usually billed for cases of similar type based on the experience of LAS staff in processing accounts and the practice of law.
- The nature of the exceptional circumstances.
- What a client of modest means would pay.
- The work done by a lawyer based on the information provided in the lawyer's request.

Protection Application – no protection order made
Motion – temporary care and custody – no temporary care and custody order made

 \Box Motion – summary judgement on protection application – successfully defunded and/or costs awarded

 \Box Status review

Complexities

Child or parent special needs (e.g.: mental illness, addiction)
Sexual or serious physical abuse allegations (criminal charges)
Indigenous factors, band issues

Relevant factors

Disclosure
Forensic / expert evidence
Multiple children / parents / parties
Timelines / reduction in appearance through mediated / negotiated settlement

□ Well funded litigant

Guidelines: Family – Support, Custody, Access

Results Obtained

□ Motion for interim spousal support – award at high end of spousal support guidelines

□ Motion for interim child support – retroactive to date of application or, support ordered other party "in loco parentis"

□ Access, custody: custodian successful in mobility application or, change in "de facto" custody due to parental alienation

□ Change in interim custody

 \Box Contested no access order

Complexities

□ Child's special needs (e.g.: mental illness, addiction)

□ Self-employed payor, imputing income for child support

□ Sexual or serious physical abuse allegations

□ Hague Convention matters

Relevant factors

□ Disclosure

□ Forensic / expert evidence

□ Multiple children / parents / parties

□ Timelines / reduction in appearance through mediated / negotiated settlement

□ Client out of jurisdiction

□ Well funded litigant

How do I request an 'exceptional circumstances' payment?

Complete the Exceptional circumstances payment (ECP)request form. Attach the form to the specific account for which a request is being sought; an ECP request form should not not be sent separately from your account.

Complete a separate ECP request form for each account you submit for work completed during the service period of that account.

Submit your ECP Request and account by emailing LAS Central PBAccounts@legalaid.sk.ca with the subject line ECP Request

Reasons for reducing or denying EC requests

Hours requested reduced:

- Hours exceeded those usually billed for cases of similar type based on the experience of LAS staff in processing accounts and the practice of law
- Hours exceeded that which a client of modest means would pay

Hours requested denied:

• Counsel failed to establish exceptional circumstances that would warrant an increased fee
