

DISBURSEMENT REQUEST FORM: EXPERT, SPECIALIST, DNA TESTING

Prior approval of the Private Bar Services Director or designate is required for services of any experts or specialists for court proceedings, including preparation, testimony and DNA testing (determination of parentage).

When the lawyer can establish there is professional merit in retaining an expert or testing, and where it amounts to a reasonable expenditure in the context of a client of modest means, the Private Bar Director will approve the request. There is no fixed maximum; the expert and DNA test fees must be considered reasonable.

Witness fees are paid in accordance with the provision of the Rules of Court. (Out of province witness fees must be approved by the Private Bar Services Director or designate before incurred).
